**Roscommon Sale** – Friday, May 11<sup>th</sup> (Closing date for entry – Tuesday April 17th)  
Bulls born on or between 01/11/16 & 31/05/17

Please find listed below the entry requirements for this Society Sale.

### 1. Whole Herd Performance Recording

It will not be a requirement for entry to be a participant in the ICBF WHPR Scheme. However Participants will be acknowledged in the Sale Catalogue

### 2. Society Sales – Entry Fees

Sale	Per Animal Entered
Roscommon May Sale	€35

(€20 refund for animals failing inspection or who are withdrawn prior to catalogue)

### 3. Testing Requirements

Roscommon May Sale – Export Standard advised but not compulsory

### 4. DNA Sampling

Council strongly encourages Breeders to have all animals offered for sale parentage verified either through standard DNA or through the new Genomics Scheme and this may become a condition of entry.

### 5. Entry Numbers Per Breeder

#### Maximum Entry Numbers Permitted for “A” Members

- 10 Registrations in 2015 – 4 Entries per sale on a 3 + 1 rule (not greater of 3 of one sex)
- 11 – 20 Registrations in 2015 – 6 Entries per sale on a 4 + 2 rule (not greater of 4 of one sex)
- 21 – 30 Registrations in 2015 - 8 Entries per sale on a 5 + 3 rule (not greater of 5 of one sex)
- 31 – 40 Registrations in 2015 - 10 Entries per sale on a 6 + 4 rule (not greater of 6 of one sex)
- 41+ Registrations in 2015 – 12 Entries per sale on a 7 + 5 rule (not greater of 7 of one sex)

#### Maximum Entry Numbers Permitted for “B” Members

- On a 50% Scale to that for “A” Members listed above.

8. **Johne's Testing** –

Export customers are indicating that Johne's Free Accreditation would be a major advantage on animals that they would consider purchasing. Breeders are asked to be mindful of this and to consider having animals and their dams tested in advance of TB Testing. Another notable point is to, if possible, ensure that samples are sent to a CHECS Approved Lab.
