Please find attached the Simmental Society Membership Form, ICBF Permission Form & Bank Direct Debit Form. Please complete **all three forms** and return to the Simmental Society.

**How to Pedigree Register a Calf:** Calves are Pedigree Registered at the time of registering with the Department for their Blue Card. If registering either by the Animal Events Book or Online, simply add a Pedigree Name in the Pedigree Name Section and this will trigger the registration to the Simmental Society. Remember your Herd Name is logged with the Society so it's just the **second name you enter and for 2023 this name must start with the Letter "R"**. (If you are not already using an Animal Events Book or registering Online this application will automatically send you out an Animal Events Book. **Note:** If you have already registered your calves for their Blue Cards then send in their Tag Numbers and names with this application.

## **Year Letter For 2023 (R)**

- The name of all calves born in 2023 must begin with the letter 'R' i.e. **Rodger, Ruby, Rolo, etc.**

**Under New European Legislation, there can be no cut off point after which animals cannot be registered.**

**Therefore animals of any age can be registered. In view of this Council has agreed the following LATE**

**REGISTRATION Rules / Costs.**

**Late Registration Fees / Procedure:** All calves must be registered within 30 days of birth to fall under the normal registration fee. However calves can be registered up to 150 days after the standard 30 days (i.e. 6 months old) through Animal Events, with the following fees applying:

- 31 - 60 Days of Age +€15
- 61 - 90 Days of Age +€30
- 91 - 180 Days of Age +€2 per Day up to €300 + DNA at owners expense

**Members wishing to register animals over 180 days of age (i.e. 6 months) must apply to the Society Office for Council attention. The fee for all animals over 180 days of age is €500 + DNA (€40) of animal against its sire, at owner's expense.**

**If the Member applying to register an animal is other than the breeder, then the registration application must be accompanied by a letter of consent from the original breeder and forwarded to the Society Office with registration application.**

**De-registration:** A breeder may choose to deregister a heifer under two years. Should a breeder or subsequent owner choose to re-register the heifer at a later date, the heifer may be registered under the same conditions as a late registration i.e. incur a late registration fee and must be DNA typed at the breeder/owners expense, €40.00.

**If the Member applying to re-register an animal is other than the breeder, then the re-registration application must be accompanied by a letter of consent from the original breeder and forwarded to the Society Office for Council attention.**

**A DNA Sample is require to be processed through Weatherbys (at the expense of the Breeder seeking registration) on all new SIRE'S entering into the Herdbook.**

- Calves with gestation lengths of over 300 days will have to be DNA typed at the breeder's expense.

**Annual Membership: Please note that your Annual Membership of 50 euro is due for payment by February of each calendar year.**
