## **Conditions of Sale Entry**

- Heifers must pass a pre sale inspection prior to entry into the catalogue.
- Each animal listed must be accompanied by entry fee of €5. Note there will be no refund where a heifer fails inspection.
- All heifers to show on their National ID Cards SI or SIX (the cross being a Simmental bull).
- All heifers to be registered in the sellers herd for a min. of 3 months prior to the sale date (no dealer's cattle allowed).
- All sellers to know the breeding of their female's eg bloodlines of stock bull or AI.
- Testing Requirements: Export Tested recommended but not a requirement
- All in-calf heifers in calf to AI should have an accompanying AI docket.
- If in-calf to a stock bull, have an accurate service date accompanied by a photocopy of the bull's pedigree certificate.
- All Maiden heifers are to be genuine breeding heifers i.e. never having had a calf and having the ability to go in-calf.
- Only cattle entered on official entry forms will be admitted to the sale.
- All cattle to be penned by 4pm on evening of the sale.
- The committee reserves the right to refuse admission or to reject entries.
- Heifers are deemed to be maiden unless entered in the in-calf section – onus on the breeder/exhibitor.

– Only signed entry forms will be accepted

Closing Date for entries is 15th of April to allow for time for inspections and to advertise numbers and have catalogue ready for sale
