Once your Permission Form is submitted to ICBF you will receive an Animal Events book (if you are registering on line or have an Animal Events book you will not receive another book).

#### **Registration Process:**

On receipt of your Membership Application you will be given a Herd Name and this will apply to all your Pedigree Animals. By putting a Pedigree Name in the relevant column either on line or through the AE book you will trigger a Pedigree Registration. In Dairy Animal there is no set naming procedure so most Breeders will follow female lines etc when naming their animals.

#### Dam & Sire Pedigrees

Please note that the Pedigrees of all Dams and Sires that are new to the system must be forwarded to the Simmental Office for compiling onto the Database in order to allow the Registrations to be processed. In the case of all Sires we also need a DNA Profile for future reference.

## Fee Structure.

Below is a table of the agreed Fee Structure. Please note that an agreed amount of each fee is being allocated to a Dairy Fleckvieh Fund for future Breed Promotion etc.

#### **Herdbook Rules**

These Rules are currently being finalized and will be circulated to all Members once completed. However below are a number of the most important finalized rules.

- All animals in the Irish Simmental Dairy Fleckvieh Herdbook will be identified by their NID tag number.
- Animals whose parents & Grandparents are registered are eligible for entry into the main section. All other will be in a grade up section.
- Imported animals must be registered in the relevant (full Pedigree section) in their country of origin.
- All Sires of calves born in Ireland must be DNA Typed
- All calves must be born within an agreed gestation period. Animals outside this window
  may have to be DNA typed at the Owner's expense.
- All Members must be on Direct Debit.
